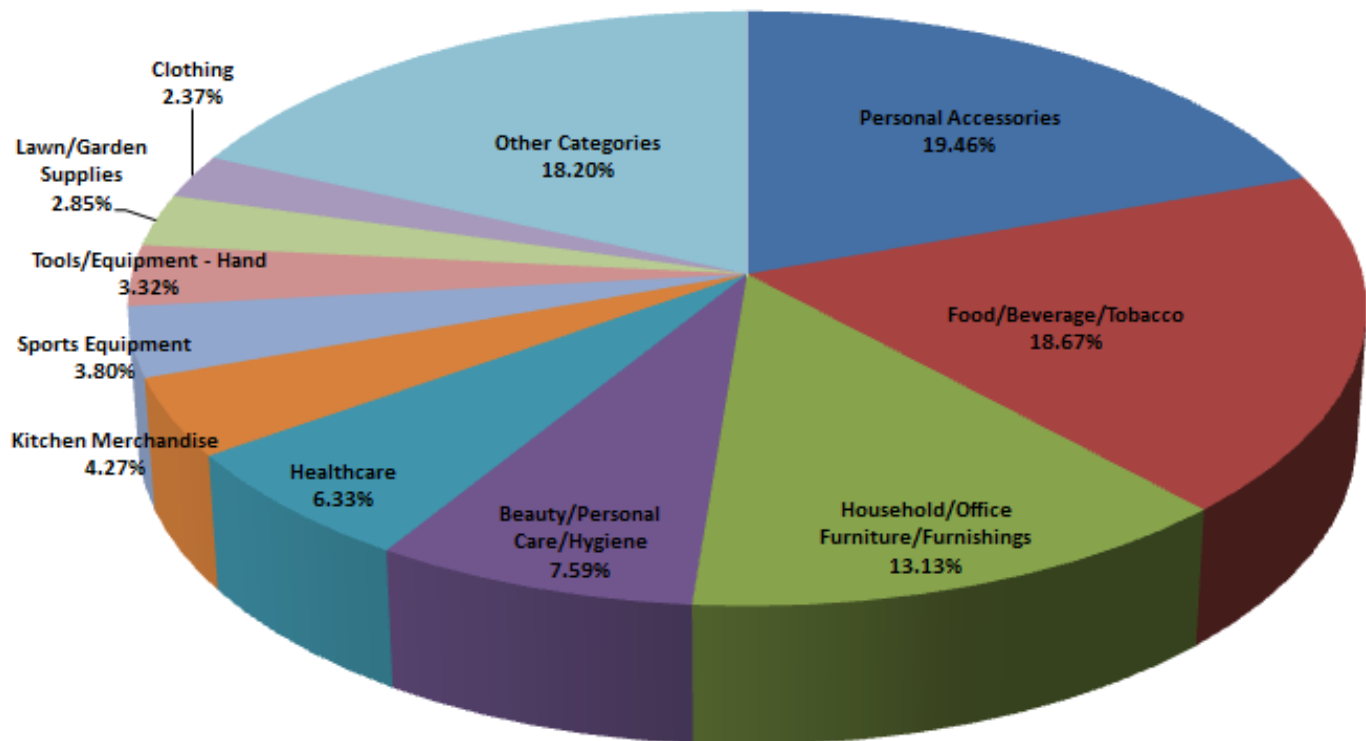
CA Proposition 65 – 60 Day Notice Summary for Q2 2019 August 2019

ENFORCEMENT TRENDS

- The first sixty day notices for Perfluorooctanoic acid (PFOA), Hexavalent Chromium, and Styrene were issued.
- Over 50 sixty day notices were issued for the exposure to phthalates for various types of product packaging.
- The six listed phthalates continue to be the main focus of enforcement, responsible for nearly 67% of the sixty notices issued.

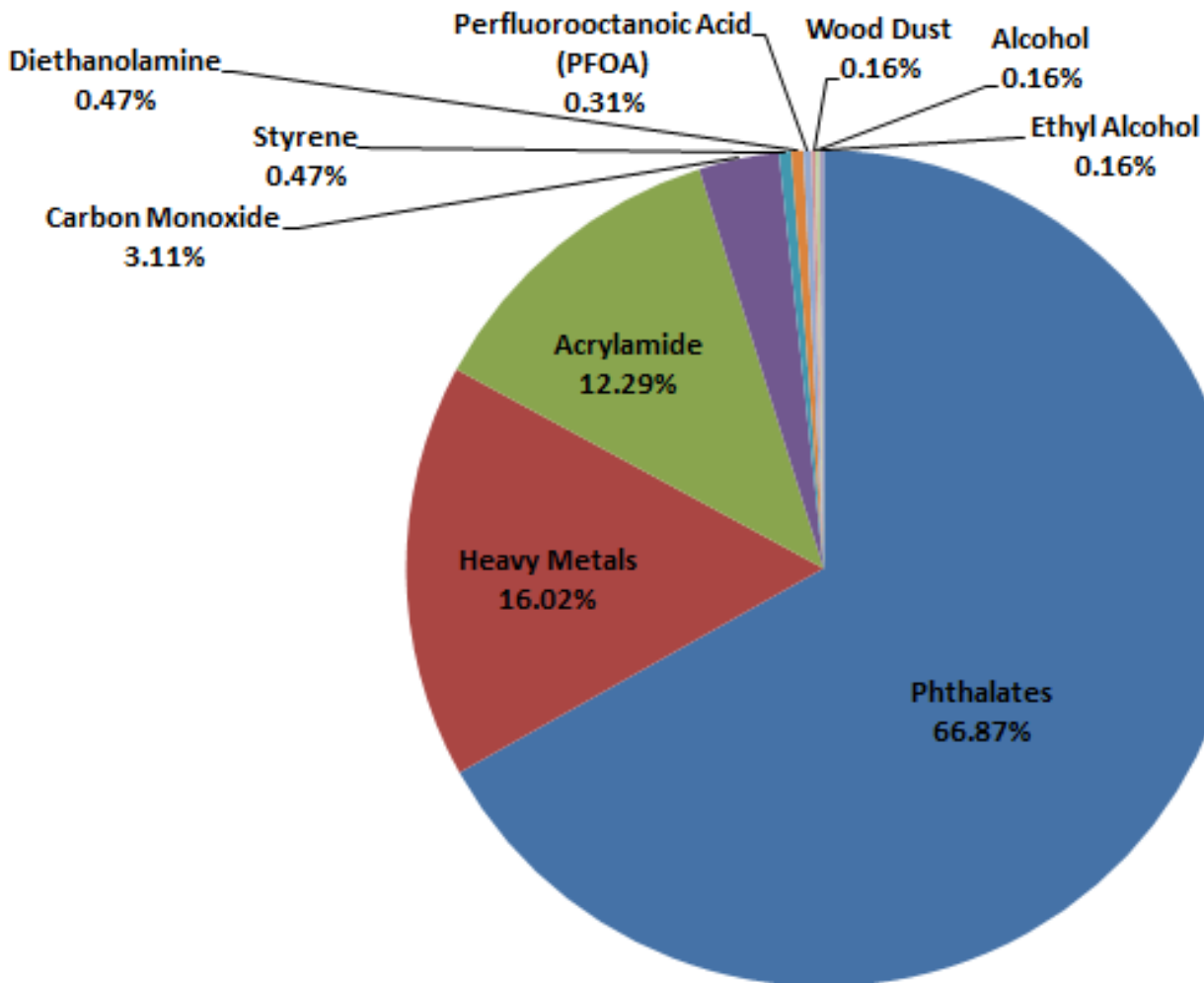
